Throughout our lives we are told we must file various paperwork with various governmental agencies. Among the items involved are deed to property and real estate, motor vehicle documents such as the Manufacturer's Certificate of Origin on cars, trucks, motorcycles, airplanes, mobile homes, motor homes and the like, and even birth certificates and applications for them, and even commercial paper.

All these documents are essentially certificates of title to the goods listed on the face of the document.

The reason I want you to think carefully about this subject is made clear in a single paragraph taken from a book called "The Law of Fraudulent Transactions" written by Professor Peter A. Alce's (Warren, Gorham & Lamont (1989) of the University of Alabama School of Law.

On Page 3-192, Section 3:97, Professor Alces lets the cat out of the bag by writing:

## § 3:97 Rights to documents of title acquired by due negotiation

The concept of reification is central to the law governing documents of title. A holder of a negotiable document of title owns not only the document but the rights to the goods evidenced by the document as well. In fact, it is probably better to be in possession of the negotiable document of title concerning goods than it is to be in possession of the goods themselves. The owner of the document is the true owner of the goods; the party in possession Page 2 of 3

of the goods is essentially a bailee of someone else's property, and cannot transfer title to the goods.

Read this carefully, Folks. It says what it says and you better get a grip on the overall ramifications of this concept.

Many of you will not really understand what it says due to one word.."reification".

Let's explore that word in Black's Law Dictionary, 5th Edition at page 1157: "Reif - A robbery"

Yep! That's right folks. You've been tricked again by the attorney cartel who, through long effort and manipulation, have set into place a <u>concept of robbery</u> to wrest from you all your property by getting you to give the governmental agencies the documents of title to your house, land, cars, truck, etc., commercial paper, and your children.

You may not like what you are seeing in this article, but you damn well better get a full scope of perspective as to how widespread and invasive this perfidious scheme really is.

You don't own squat! You gave it all away to the government when you gave the government the documents of title to whatever.

I challenge anyone to prove this wrong as a matter of law and fact.
